- Description:** PIONEER 1-L may carry up to two (2) unirradiated uranium dioxide fuel assemblies for an APR1400 nuclear power plant.
- Drawings:** PIONEER 1-L packaging is manufactured in accordance with KEPCO Nuclear Fuel Co., Ltd, Drawing No. A0-7A7D2-950-P01 (Rev 4).
- Contents:** Unirradiated uranium in the form of uranium dioxide fuel pellets contained within fuel rods. The <sup>235</sup>U enrichment shall not exceed five (5) percent by weight total uranium.
- Criticality Safety Index (CSI):** Zero (0)  
The criticality safety analysis of the package is documented in "Request for FANR's Multilateral Approval of the Fresh Fuel Shipping Cask", Enclosure 3, dated 27 April 2012, and "Safety Analysis Report for the HERMES PWR Fresh Fuel Shipping Package", Rev D.
- QA Requirements** The QA requirements are documented in "Request for FANR's Multilateral Approval of the Fresh Fuel Shipping Cask", Enclosure 4, dated 27 April 2012.
